

TERMS OF REFERENCE FOR THE REMUNERATION COMMITTEE UNDER THE BOARD OF DIRECTORS OF

WENZHOU KANGNING HOSPITAL CO., LTD.

CHAPTER 1 General Provisions

Clause 1 The Remuneration Committee is a special committee of the Board of Directors of the Company (the "Company"), established in accordance with the provisions of the Company Law of the People's Republic of China, the Shanghai Stock Exchange Listing Rules, the Company's Articles of Association, the Company's Articles of Incorporation, and the Company's Internal Rules of Procedure. The Remuneration Committee is responsible for reviewing and approving the remuneration policy and the remuneration system of the Company, and for reviewing and approving the remuneration of the Directors and the Senior Management of the Company. The Remuneration Committee shall be composed of three (3) independent non-executive Directors, and the Chairman of the Remuneration Committee shall be an independent non-executive Director. The Remuneration Committee shall have the authority to recommend or advise the Board of Directors on the remuneration of the Directors and the Senior Management of the Company, and to monitor and evaluate the performance of the Directors and the Senior Management of the Company. The Remuneration Committee shall also have the authority to recommend or advise the Board of Directors on the remuneration of the Directors and the Senior Management of the Company who are not members of the Remuneration Committee. The Remuneration Committee shall also have the authority to recommend or advise the Board of Directors on the remuneration of the Directors and the Senior Management of the Company who are not members of the Remuneration Committee.
